Player Agreement

ULTIMATE BOWLS PAID REGISTERED PLAYER (Player)

BACKGROUND

- A. Ultimate Bowls owns and operates the UBC.
- B. The Player wishes to participate in the UBC.
- C. This Agreement records the terms on which Ultimate Bowls grants, and the Player accepts, the right to participate in the UBC.

1. Term

This Agreement is for the following calendar year only and automatically terminates on December 31st 2020.

2. Grant of Right to Participate in UBC

Ultimate Bowls grants, and the Player accepts, the right to participate in the UBC during the Term, subject to the terms and conditions set out in this Agreement.

3. Ultimate Bowls' General Rights and Responsibilities

- 3.1 Ultimate Bowls will:
 - 3.1.1 Plan, manage and host each Event at the venue.
 - 3.1.2 Organise a venue for each Event.
 - 3.1.3 Supply a pool of coloured bowls. However, there is no guarantee that a particular size and model will be available at all times.
 - 3.1.4 Supply the Team uniforms.
 - 3.1.5 Provide accommodation for all players.
 - 3.1.6 Develop, administer and enforce the UBC Rules and Regulations.
 - 3.1.7 Comply with all applicable Law.
 - 3.1.8 Identify and provide all personnel, processes and resources required to meet its obligations under this Agreement.
 - 3.1.9 Pay out the player's prize money share to the team owner only if this agreement has been complied with.
- 3.2 Ultimate Bowls has the exclusive right to:
 - 3.2.1 Determine the schedule of Events in respect of each Tournament Year.
 - 3.2.2 Set the amount of the Prize Pool in respect of each Tournament Year.

- 3.2.3 Amend the structure and format of the UBC during the Term, including the Rules and Regulations, scheduling and location of Events and the timing of the UBC in any Tournament Year.
- 3.2.4 Withdraw a player from competing in an Event should the player be convicted of any offence that would bring discredit to the UBC, or a bowling association has disqualified or banned the player from playing in other bowling events, or the player has breached the 'Code of Conduct' set by the UBC.

4. Player's General Rights and Responsibilities

- 4.1 The Player will:
 - 4.1.1 Pay an annual registration of \$25 (AUD) to be allowed to participate in player pre-selection and the Draft. This is payable by the 20th of December each year, for the following calendar year.
 - 4.1.2 Play in the team selected on the draft night. If they decline, they will be unregistered with UBC and may be banned from registering again with UBC.
 - 4.1.3 Acknowledge they may not be selected on the draft night and are not entitled to a refund of the registration fee.
 - 4.1.4 Acknowledge they can withdraw from the UBC Player registration list at any time prior to the Draft night however, are not entitled to a refund of the registration fee.
 - 4.1.5 If pre-selected prior to the draft, have the right to decline to join the team making the selection.
 - 4.1.6 Be available for all the events during the year, unless incapacitated and so unable to play.
 - 4.1.7 Wear the team uniform, wear nothing that compromises the sponsors at the particular venue and will play with the coloured bowls prescribed by UBC.
 - 4.1.8 Have the opportunity to elect to go into the draw for a position in the UBC Wild Card team (at the time of registration), if the player is not successful in securing a position in a team by the end of the Draft.
 - 4.1.9 Have the opportunity to be selected into one of the Hong Kong Qualifying teams.
 - 4.1.10 Acknowledge that individual and team playing statistics derived from the UBC scoring software will be used in promotional posts, website updates and on the UBC app.
 - 4.1.11 Acknowledge that a position the UBC Wild Card team grants the player the opportunity to play in only one of the three events for the calendar year.
 - 4.1.12 Acknowledge that an offer of a position on the UBC Wild Card team can be declined by the player.
 - 4.1.13 Acknowledge players will share a minimum of 30% of any prize money won by their team (remainder goes to the team owner). In the case of the wild card team, only the three players at the particular event are eligible for prizemoney, except for the bonus \$20,000 (AUD) where the 30% players' share will be divided between the nine Wild Card team players.
 - 4.1.14 Acknowledge UBC corporate partners may email promotional material from time to time.
 - 4.1.15 Abide by the UBC 'Code of Conduct'.

5. Governing Law

This contract is made under the laws of Australia.
